## Judge, Lauren Kussro

Kussro received a BFA in Painting and Printmaking from the Herron School of Art & Design at Indiana University – Purdue University, graduating with high distinction. In 2006, she completed her MFA in Printmaking at the University of Tennessee in Knoxville. Kussro currently teaches printmaking at the University of Houston – Clear Lake, where she is an Associate Professor of Art and Design.

Kussro's work has been shown around the country: with solo exhibitions at Vanderbilt University in Nashville, TN, the Bradbury Art Museum in Jonesboro, AR, juried exhibitions at Kai Lin Art in Atlanta, the Dadian Gallery in Washington D.C., and the Manhattan Graphics Center in New York. Her creative research is centered in a playful investigation of the natural world.

#### **Artists**

Open to all artists over the age of 15, regardless of membership status.

#### **Entries**

Artists may enter up to **three** works in any medium. This is a juried show, which means your work might not be accepted. Those works accepted can be for sale but must remain at the gallery for the entire exhibition period. Works must be:

- 1. Created in the last 4 years and not previously accepted in a juried show at the Galveston Art League.
- 2. Original work of the artist who physically integrates/manipulates every component of the original concept and design.
- Installation ready with mat, finished edges, cabled/wired frame (NO SAWTOOTH HANGERS OR HOOKS), glass or acrylic, and hanging device in place where appropriate. Framed works larger than 24 inches in any direction must use Plexiglas or acrylic. See full criteria at https://galvestonartleague.com/exhibits/how-to-submit-work/.
- 4. Less than 5' X 5' and two people must be able to easily carry/hang all work. Works larger than 150" around the perimeter, count as 2 pieces.

Artists must adhere to the above criteria and the published dates and times. Works that do not meet these criteria will not be hung, even if inadvertently accepted into the show. If unable to make a scheduled pick-up time, artists must inform the gallery and arrange for pickup or works become property of the Galveston Art League.
